During the period from July 1, 2007 through June 30, 2016 we have served 482 men. Over the last 9 years, 238 residents have stayed in our program 90 days or longer. Of these residents only 13 lost their parole and returned to prison. Out of the 23 current residents, 15 all are employed. Over the past 9 years, 5 residents have obtained associates degrees from Houston Community College in various fields.
